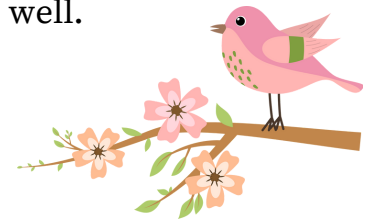


Message from Your Manager

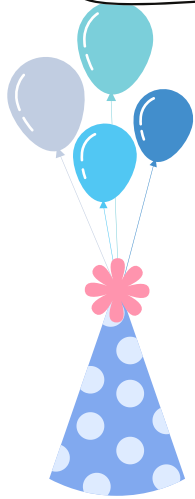
