### What to Bring

- Guests are responsible to bring clothing that is clean and in good repair.
- Please bring all your own personal toiletry items.
- The care and storage of personal items are the responsibility of guests. We recommend that guests not store valuable items such as jewellery or large sums of money in their suite. Guests are responsible to ensure that their suite is locked at all times.
- Telephone Guest suites do not have a telephone, therefore guests are asked to bring their own cell phone.
- Medication You are responsible for supplying and taking your own medication during your stay.

#### Keys

- Guests will be issued one key to their suite upon arrival.
- The key must be returned by 11:00 a.m. on the day of check-out. Guests who do not return the key will be charged an additional \$100.00.

#### **Parking**

# Pets

Pets are NOT permitted to stay at the Guest House.

## **Visiting Hours**

Guests are permitted to have family and friends visit. There are no pre-set visiting hours, however, it is expected
that common courtesy will be observed with respect to noise, etc. Quietness must be maintained after 11:00
p.m.

#### **Smoking**

- Smoking inside the premises, including suites, is prohibited.
- Smoking is only allowed outdoors in designated smoking areas.
- Please check with management regarding smoking as it is possible there is a designated smoke room.
- All guests must utilize ashtrays for their cigarette butts.

#### Alcohol

- The use of alcohol or other substances to a degree that would cause disruption to others is not tolerated.
- Guests who are intoxicated to such a degree that is disruptive to the quiet enjoyment of our residents will be asked to leave immediately.

#### Meals

- All stays include a breakfast and supper meal. Lunch is available for a nominal cost. In order to facilitate
  planning, lunch must be pre-booked and pre-purchased. Further information will be provided at check-in.
- All meals are served in the dining room which is a congregate setting. As such, guests are expected to dress
  appropriately for meals. Pyjamas are not permitted.

#### Laundry

 Complimentary laundry facilities are available. You may bring your own detergent and fabric softener with you or purchase on site. Please note that liquid bleach is not permitted.

#### Housekeeping

- Your suite will be provided with light housekeeping services once per week which includes a change of towels (one bath towel, one hand towel, and one facecloth) and sheets. The carpet will be vacuumed, the bathroom floor will be washed, and bathroom fixtures disinfected. It will be the responsibility of guests to make their bed each day and keep their suite tidy.
- Guests are not permitted to take dishes or cutlery from the dining room or kitchenette area to their suites.

#### **Life Enrichment Activities**

- Guests may participate in lodge planned activities inside or outside the premises. The Guest assumes all risks associated with these activities and agrees to pay any applicable costs.
- Exercise and recreational equipment is available on site and may be used by Guests. The use of said equipment is at the Guest's own risk.

During their stay, guests will have access to a shared kitchenette and the use of complimentary laundry facilities. The shared kitchenette is complete with snacks, fridge, microwave, toaster, kettle, and coffee maker. Breakfast and supper are included, and all meals are served in the dining room area.

All suites include a Shaw digital cable box and remote control that must remain in the suite. Failure to comply will result in a charge to the guest for a replacement digital box and/or remote control.

The premises is staffed 24 hours a day, 7 days a week and is a barrier-free accessible facility. The staff are committed to providing guests with excellent service and a safe, secure environment.
